- 6. No inventory of guns, new or used*
- 7. New firearms not kept more than 24 hours*
- 8. No fully automatic weapons*
- 9. No exotic bullets i.e. Black Talon, Armor Piercing, Armor Defeating etc.*

- 10. No discharging of firearms on the premises
- 11. Weapons to be sold to law enforcement personnel only
