SPECIAL MEETING/MARCH 21, 2002

The special meeting of the Prairie Township Board of Trustees, which was posted in three places in the Township, was called to order at 1:00 p.m. by the Chairman, Mr. Nourse, with Ms. Keller and Ms. Kay Henderson; Ohio Bureau of Workers Compensation present.

The purpose of this meeting was for Ms. Henderson to review with Prairie Township "decision makers" the requirements, elements and participation in the Ohio Bureau of Workers Compensation's Drug Free Workplace Program.

Ms. Henderson described the three levels of the program with Level 1 being an entry level, which could be implemented by June 2002 within the Township to Level 3 which includes supervisor training and random drug screening of at least 25% of all employees.

Mr. Nourse views a Level 2 program as being the maximum program necessary. The Level 2 program would involve entry level screening, supervisor training and random testing of 10% of the workforce.

Ms. Keller agreed stating that now is the time to initiate such a program since we do not have a problem with drug/alcohol abuse among our workforce.

Ms. Henderson indicated that a Level 2 program could be in place by January 2003. A Level 2 program would provide the Township with as much as a 20% reduction in our current BWC rates. Also, after 1 year of successful participation, the Township would be eligible to participate in a BWC's Premium Discounts Plus and Safety Grants programs.

There being no further business for the Board the meeting was adjourned at 2:30 p.m.
